DOS search raises questions of conflict

While the actions of the Cumberland County Board of Education often impact all employees of the school system, it has but one employee: the director of schools.

As the board moves forward with its search for a new director, one board member will be faced with the dilemma of evaluating her son for the position.

Shirley Parris, 3rd District representative, faces this no-win situation as her son, Darrell Threet, moves into the interview phase of the search process.

If she votes for him, there will be a question about if the vote was based on qualifications or nepotism.

Messages to Parris over the weekend were not returned at press time, so we do not know what she plans to do. However, when this same situation occurred in the 2016 director of schools search, she did not step down from the hiring process.

Board policy 1.108 requires the board to be notified before anyone is hired in the school system who is related to a member of the board, the director, an administrator, a county commissioner, or any appointed or elected county officials. No person is to supervise or be directly supervised by an employee if he or she is related to the employee.

There are several members of the board with familial relationships with employees of the school system. Unlike the county commission, no member of the board can be directly employed by the school system. But board members with a conflict of interest created by their family relationships declare these conflicts, often at the start of each meeting.

Board members with registered conflicts are Parris; Jim Inman, 1st District representative; Robert Safdie, 2nd District representative; Tony Brock, 5th District representative; and Teresa Boston, 8th District represen-

Who is protecting the nurses at CMC?

Dear Chronicle:

Nurses, caring, committed and protective of their patients — but who is protecting CMC Covenant Health nurses? As a seasoned nurse I am seriously concerned for the health and safety of nurses at CMC during this COVID pandemic. The CDC and WHO both agree nurses should have N95 respirators for personal protection and a pre-symptomatic stage (between exposure and onset of symptoms) when the person is contagious but does not show symptoms exists. If COVID can be spread by those who show no symptoms and N95 respirators are the accepted protection for nurses, then why are many CMC nurses in cloth masks rather than N95 respirators? At CMC only nurses who are in direct contact with symptomatic patients receive proper protection with N95 respirators. The rest must use cloth masks and be at risk of contracting COVID. I doubt this is the nurse's preference but rather administration's directive.

Nurses are on the forefront of this pandemic. In the ER, medical-surgical unit, or OB unit assisting with the delivery of a baby and postpartum care of the mother, nurses are up close and personal in the delivery of their care. Nurses are at risk for exposure to COVID every shift they work at CMC but with N95 respirators they decrease their risk of dying from COVID-19. Nurses are not expendable; they should not have to sacrifice their lives where they work. All nurses need proper protection with N95 respirators provided by CMC Covenant Health. The community should advocate for safety of our nurses!

Anyone can become a victim of crime at any time — although I never thought I would become

I first met Chris in 2006 and we quickly fell in love. We moved in together and began planning and building our life. We talked about our dreams and our goals to start a family.

Then on October 26, 2007, what started as the best day of my life, ended as the worst and changed my life forever.

When we woke up that morning, Chris asked me to marry him. We spent the day looking at rings and talking about our

Chris went to work that night as he always did, but shortly before he was supposed to close the restaurant he worked in, someone came in and forced him to hand over all the money in the safe before asking him to lay down on the floor. Moments after that, the offender shot Chris and another coworker, Josh, in the back

of the head as they both lay faced down. Chris was 33, and Josh was only 18.

When Chris didn't come home from work, I continually called him without getting an answer. I knew this was not like him, so I got in my car and drove to his work, hoping his car wouldn't be there and maybe he just forgot his phone. Sadly, it was just the opposite, his car was there and so were many

other emergency vehicles. I quickly got out of my car and asked if Chris was okay, begging for answers. Then, I saw a face I recognized walking towards me with a look that told me everything I needed to know. Chris was gone.

At that moment, I, too, had become a victim of crime. But I had no idea

what to do next, much less what rights I had. All I knew was I was going home alone, and Chris was never coming home again.

Thanks to the wisdom of our legislators and their leadership in passing the Crime Victims Bill of Rights in 1998, most victims of crime have their rights spelled out in the Tennessee Constitution But unfortunately, the way it is worded means that those rights didn't apply to me and in too many cases, the rights that are meant to be guaranteed for other victims are not enforceable under the current law.

That's why I am a part of a movement in Tennessee to strengthen the constitutional rights of crime victims by passing what is called Marsy's Law. When the legislature returns to session, we strongly urge them to take up and pass Marsy's Law this year to strengthen the constitutional rights of crime victims and to make them enforceable.

The Marsy's Law bill

must pass two consecutive legislative sessions before the constitutional amendment will be placed on the November 2022 ballot for

voters to approve. Whenever a person is arrested for committing a crime, they are read their Miranda Rights and given instructions on what is going to happen to them next. But I can tell you from firsthand experience, as a crime victim, we are thrown into a situation we've never been in before, with no support and no idea what to do next.

I learned a few days after Chris' death that because we were not married, his family, who lived in other states, were the only ones with any rights. While I absolutely agree his family should have rights, I too, as his partner and future wife should have been included.

I was the person who lived with him, paid bills with him, and had dreams to build a family with

Due to the current COVID-19 pandemic, Cumberland County commissioners approved a resolution to change the county's personnel policy, adding a few paragraphs to address county employees working from home and administrative leave.

"Certain policies needed to be added for audit purposes," the resolution states. "Although the county offices following the policies do have some employees that are working from home, none are on administrative leave."

The additions to the policy include the follow-

Teleworking/working from home

During the threat of all types of major emergencies and disasters, both natural and manmade, the county mayor may determine temporary changes are needed in the operation of county government.

"The determination must be made in writing and be provided to all county-wide elected officials and the county commission. During that time, the Cumberland County mayor or elected official may allow employees to work from home as needed," the resolution states. "Employees will follow processes created by the mayor or elected official

in regards to timekeeping, requirements for work, and supervision of the employee in accordance with the Fair Labor Standards Act."

Administrative leave

"The county mayor or elected official may reduce or suspend normal operating hours for certain offices or departments or may grant additional paid leave to full and part time employees, within the confinements of the budget and in accordance with local, state and federal laws," the policy states.

The county commission unanimously approved the resolution and changes during its teleconference meeting Monday night.

The county commission approved the following board appointment resolutions during its April 20 teleconference meeting:

Cumberland County Board of Equalization members appointed are Willie Freeman, Bill Hargis, Daniel Husk, Levonn Hubbard and Rhonda Rector. The board reviews property owner complaints during annual property tax assessments. Members must complete a minimum of four hours of annual training as provided by the Comptroller of the Treasury.

pay and benefits and policies for the operation of the school system. They can also approve agreements with the teachers. These decisions will impact their loved ones and every other employee.

They grant tenure to teachers meeting certain criteria, and they are the final appeal in grievances or disciplinary action.

But they are not part of the hiring process for anyone other than the director of schools. They are not responsible for supervis-

ing or critiquing any other employee of the school system other than the director.

That kind of direct supervisory and employment relationship requires a higher level of discernment than the general conflict-of-interest statement. For the process to move forward without the stain of nepotism or favoritism, Parris must step aside and allow the eight board members to determine the fate of the four local can-
