Other Tennesseans could be honored

A great deal of discussion in the past several weeks has swirled around a day proclaimed in honor of Confederate general Nathan Bedford Forest and a bust of his likeness on display in the Tennessee Capitol.

Last week, the Tennessee General Assembly effectively ended discussion by voting to keep the statue and the day in his honor.

A House committee voted 11 to 5 to keep the statue. The Senate voted to keep July 13 as Nathan Bedford Forrest Day in Tennessee, though they did change the law so Gov. Bill Lee doesn't have to sign the proclamation.

Some have decried the efforts to end the recognition of Forrest as an effort to erase history. But what we choose to honor with statues or holidays says a lot about what we value as a state. Removing a statue from the hallowed halls of our government or ending the practice of setting aside a day in honor of this person does nothing to change history. And a statue does nothing to tell you about the man being honored.

Forrest was born in Chapel Hill, TN. His father was a blacksmith. He died when Forrest was 16, and the young man moved to the Memphis region where he later made his fortune buying and selling cotton, land and slaves.

He volunteered as a private in the Confederate army, but he decided to bankroll a unit. He was commissioned as a lieutenant colonel.

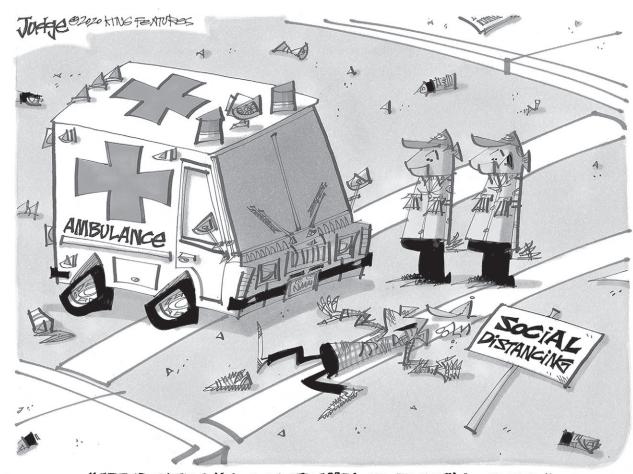

ing forward to putting the COVID-19 pandemic in our rearview mirror, it is imperative that we focus on what still lies ahead of us. This crisis, like any other, constantly forces us to evolve, adapt, and become more productive in our post-pandemic world. Society will inject new ideas and make them our new normal.

The one constant Tennesseans remain resilient! We mobilized and adapted quickly to protect our families, neighbors and communities from COVID-19. Our health care system swiftly reacted to fight this silent virus. Hospitals immediately increased their capacity and medical researchers began working on a cure; everyone contributed.

As we seek to develop and research medications and vaccines to stop the coronavirus, our innovations will not be limited only to research and development. The patient-centered health care model initiated during the pandemic will continue bringing new innovations and

efficiencies into the marketplace.

Regardless of which sector of our economy we want to discuss, there will be people who push toward innovation and those who shy away. Change is difficult; but change can turn the status quo upside down. In health care, telehealth is one example of turning the status quo upside down. This concept isn't a new idea for Tennessee, and each year, we have gained a little more momentum in our pursuit of becoming a national tele-health leader.

I have heard President Trump, federal and state officials, as well as health experts continually promote tele-health. Hospital executives have also shared their thoughts with me about its value and importance and what telehealth means for the future of health care delivery in

has provided a mechanism to continue caring for patients and monitoring diseases or aliments efficiently and effectively during the pandemic. Traditional visits are no longer necessary in certain situations that would have required time away from work, such as routine check-ups, physical therapy, mental health and follow up visits.

As a child, my grandfather would tell me stories about the local doctor carrying around "the black bag." This was just his way of describing house calls because patients were not always required to come into a doctor's office or clinic in those days. What's the difference between then and now? The doctor was in charge of a patient's needs; this is not true today. Some things were also just easier back then — but that doesn't mean we can't make them easy again. In fact, tele-health brings "the black bag" approach back into the home, workplace or other mobile locations. It will also allow our

current and future health professionals to once again make those routine house calls to a larger number of citizens, but only if we can create a uniform payment system, and everyone is on the same page — insurers, providers, doctors and patients.

While many of Tennessee's leaders have fought for a more robust telehealth program for several years, others continue to fight against it - particularly the idea of payment parity or uniform payment for tele-health and traditional visits. You will often hear insurers say let the free-market work. I am a firm believer in free-market principles, and these principles almost always work, until you face a monopoly. To date, only BlueCross-BlueShield has made the decision to provide payment parity in tele-health, and I applaud them for it. Meanwhile, other insurers are continuing their monopolistic operations by refusing payment parity and even slashing in-network pro-

Racism is a public health crisis

We're facing a state of emergency. Not only has the death toll of the COVID-19 pandemic risen above 105,000 in the United States alone, but it seems to be disproportionately lethal for Black Americans. While COVID-19 is still a growing pandemic, it's unmasking itself as a racial injustice as well.

A growing number of communities are treating racial disparities like these as a public health issue. Last year, Milwaukee declared racism a public health crisis. And this May, amid rising racial disparities in COVID-19 deaths. Franklin County — the largJaelani Turner-Williams Other Words

est county in Ohio and home to the state's capital, Columbus — did the

But in the wake of George Floyd's death and nationwide uprisings that were often met with harsh repression, it's clear that COVID-19 isn't the only epidemic disproportionately devastating Black communities. At least 1,252 Black Americans have been shot and killed by the police since

Columbus is no exception. In 2017, the Columbus Police Department was ranked No. 1 among large U.S. cities whose police forces disproportionately kill Black peo-

In the years before Floyd's death, several incidents traumatized the city's close-knit Black community.

In December 2018, 16-year old Julius Tate was killed by the Columbus police during a sting operation. Tate's death also led to his girlfriend, Masonique Sanders, being given a threeyear juvenile sentence in conjunction with Tate's

murder, taking the fall for an injustice many believe the police committed.

By May 29 this year following George Floyd's murder, and on what would have been Tate's 18th birthday — the city was engulfed by protests many felt were overdue.

Although the county had declared racism a health crisis only days earlier, police cracked down harshly. Even elected officials who showed up to support demonstrators — including Columbus City Council members and Rep. Joyce Beatty, a 70-year-old Afri-

eral Sessions Court. The lawsuit requires again serving the property owner notice of the suit. The court could then order the property sold to satisfy the

A notice had also been served on at least one of the property occupants.

We did that in hopes that — they're the ones operating whatever is going on — in hopes they would get that cleaned up," Burnett said. If the board authoriz-

es a lawsuit, Burnett said he would need proof of the property impacting the health, safety or welfare of the community.

"If I were standing before the judge, I would want to see what those issues are," Burnett said.

The committee has photographs from when the complaint was first filed. More recent photos show wood stacked, as though for firewood. That would not be a violation, Burnett said. A photo showing an old mattress would be a violation, except it appeared the mattress was in the road right-of-way.

"With what you have written, the teeth you have deals with health, safety and welfare. You have to be able to show insect issues, rodent issues, vermin issues, mosquito issues, tires, water," Bur-

He cautioned anyone taking photographs could not take photos of someone or property where there is an expectation of

And, if the issues weren't "obvious," then there would be a question of how the situation impacted health, safety and welfare, Burnett said.

Board member Tom Isham said county property taxes had not been paid on the property since 2014. "That's \$2,453 in

taxes," he said. "But that property is not scheduled to go on the next tax sale." Burnett said it would

They were concerned about snakes living among the boxes and possibly harming a child. The property backs up to North Cumberland Elementary School, not far from the playground.

However, as the panel questioned how to proceed, it was discovered only two of the complaining neighbors own property within 150 yards of the home in question. Efforts to reach the neighbor living across the street had been unsuccessful to date, the school system owns the property to the rear and Hwy. 127 forms the side property line.

He had several victories on the battlefield and was called "the wizard of the saddle" for his cavalry attacks. He was promoted time and again until he held the rank of lieutenant general.

But Forrest's military career came with its own controversy. He was the commanding officer when Confederate troops massacred surrendering African-American Union troops at Fort Pillow in West Tennessee.

After the war, he reportedly served as the "Grand Wizard" of the Ku Klux Klan until 1869. He reportedly ordered the organization to dissolve, but history shows us that order was

not followed. The state began honoring him with Nathan Bedford Forrest Day in 1921. The bust in the state capitol was installed in 1978. The statue immediately sparked protests. The continuing controversy is nothing new.

It's time for our leaders to take a hard look at why we ever honored Forrest to begin with. Yes, he was a brilliant

general and military strategist. But his fortune was made buying and selling humans on the slave market. And while Forrest denied having been part of the KKK during a congres-

sional inquiry, a 1914 his-

tory of the KKK by Laura

Martin Rose gives details of him joining the organization nearly a year after it first formed in Pulaski,

Forrest has always been a polarizing figure, and the decision to honor him remains a polarizing choice for state leaders.

There are better options available.

We can end the practice of honoring Forrest with a day of recognition, and we can move his statue to the Tennessee State Museum.

Then we can seek to honor Tennesseans who represent our state with honor and dignity, who have given their time, talents and treasure to make this state a better place for
