Trump aquitted of impeachment charges

WASHINGTON (AP) — President Donald Trump won impeachment acquittal in the U.S. Senate, bringing to a close only the third presidential trial in American history with votes that split the country, tested civic norms and fed the tumultuous 2020 race for the White

With Chief Justice John Roberts presiding, senators stood and stated their votes for the roll call — "guilty" or "not guilty" — in a swift tally almost exclusively along party lines. Trump, the chief justice then declared, shall "be, and is hereby, acquitted of the charges."

The outcome Wednesday followed months of impeachment proceedings, from Speaker Nancy Pelosi's House to Mitch McConnell's Senate, reflecting the nation's unrelenting partisan divide three years into the Trump presidency.

What started as Trump's request for Ukraine to "do us a favor" spun into a far-reaching, 28,000-page report compiled by House investigators accusing an American president of engaging in shadow diplomacy that threatened U.S. foreign relations for personal, political gain as he pressured the ally to investigate

One person was killed in an I-40 crash, one trapped in a vehicle wrapped in live power lines and a section of I-40 close following a deluge of rainfall across the Cumberland Plateau since Tuesday.

Crossville meteorologist Mark Baldwin of WeatherTAP reported Thursday morning that he recorded 7.2 inches of rain falling at his residence in northern Cumberland County over the past 30-plus hours. It was still raining when he issued his post on social media shortly before deadline Thurs-

There were scattered reports of winds and rain-soaked earth causing trees to fall across county roads and into utility lines throughout the county. There were reports of electrical service interruptions in two sections of the county because of downed trees

There were also scattered reports of fallen trees causing damage to personal property. In the Mayland and Cow Pen Rd. areas, citizens were reporting to the Crossville/Cumberland County Emergency Management Agency that there was damage to house and to a barn caused by high winds.

The Tennessee Highway Patrol reported Donald Monday, 62, Crab Orchard, was driving a 2000 Toyota Camry east on I-40 near the 306 mile marker around 2:30 p.m.

THP Trooper Jack Alderman wrote Monday's vehicle suddenly veered sharply to the left, traveled across the left lane and into the median. The vehicle then struck two trees and landed on its top.

The crash occurred during a rain-

supervisor with Cumberland County EMS, said.

Cumberland County reports an

average response time of 9 minutes, 11 seconds from the time they receive a dispatch of a medical emergency to their arrival on scene. Those first minutes can

change the outcome for the patient. Abels noted Seattle has one of the highest rates of survival with CPR, quite possibly because the state requires everyone to earn their CPR certification when they get their driver's license.

"A lot of people may not know CPR, but they would jump in if they knew what to do," he said.

Paramedic Chris Kemmer is a CPR instructor. The department offers trainings on request, usually from organizations or businesses. The department offers the outreach as a service, though organizations do have to pay a fee for a CPR cer-

tification card. "CPR is where it starts," Kemmer said. "The numbers show anything over 10 minutes, the chance of reviving someone decreases."

8 candidates seek Property Assessor post

Eight candidates are seeking election as the next Cumberland County Assessor of Property. All candidates will be on the Republican Party primary ballot March 3 and the winner unopposed in the August general election.

Early voting begins Feb. 12.

The Tennessee Constitution establishes the elected office. The assessor is responsible for discovering, listing, classifying and valuing all property in the county. This includes land and buildings along with machinery and equipment used by a business.

Property must be properly classified as residential, commercial, farm, personal, utility or exempt.

Each classification has a different assessment level, such as 25% of the value of residential property and 40% of the value of commercial property.

The assessor must also maintain maps and inventory of property within the county and complete a reappraisal every five years to insure property values reflect current market value.

The property assessor does not set that tax rate. That responsibility falls to the Cumberland County Commission and the city of Crossville. The office also does not collect property taxes or send the tax bills. The county trustee and the city of Crossville are responsible for those

Property taxes are due by Feb. 29 for Cumberland County. The city's property tax deadline was

Nov. 30. Six of the eight candidates introduced themselves during the Jan. 21 meeting of the Cumberland County Republican Party. They are listed in the order in which they spoke following a random name drawing.

HELP: CPR, first aid courses help people respond

beating, it stops circulating oxygenated blood to the brain. The compressions in CPR help to circulate oxygynated blood. Kemmer said blood has about 8 to 10 minutes of oxygenated blood that needs to be circulated using chest compressions.

And, if someone forgets how many compressions (30) or how many breaths (2) they should be doing, the dispatcher on the other end of the phone can walk them through it.

"There is someone who can calmly tell you what needs to be done," Kemmer said.

Dan Linskens, safety manager for the Fairfield Glade Community Club, has trained more than 1,000 residents and employees on CPR, automated external defibrillators and first aid since 2017.

In 2012, he was a participant in a first aid class. The class took eight hours, required for American Heart Association certification, but was designed for people in the medical field.

"We just wanted to be community rescuers and know what to do in those first five minutes," Linskens said.

He found a course that better fit their needs and he started offering it to employees in 2013. In 2017, the Community Club expanded the courses to include residents. The course covers CPR, bleeding control and using an AED. It also covers how to respond to various medical emergencies, like allergic reactions, stroke, heart attack, diabetic emergencies, head, neck and back injuries, choking, stroke, and heat- or cold-related emergencies.

"We talk about signs and symptoms so you can recognize something before it becomes a life-threatening situation," Lin-

He also explains a person's legal responsibility and the Good Samaritan Law, which protects people who take reasonable action in an emergency.

The Community Club has helped promote the training with mannequins and the free sessions, offered to residents a few times a month. EMS can also offer training for organizations.

"A lot of people came to our classes because they witnessed an incident, and they didn't know what to do," Linskens said. "Knowing what to do makes you confident."

The county has now launched a First Responder program through the Cumberland County Fire Department. So far, about 30 volunteers have completed the training. Cumberland County Fire Chief Trevor Kerley administers the program.

"When it reaches its full potential, it will be a huge asset for the county," said Kemmer.

The city of Crossville has long offered first responder services. Several city firefighters are also paramedics and can provide emergency medical care. They answered 127 EMS calls in



November, about 70% of the calls the fire department responded to. Cumberland County Mayor


